As you are aware, the Institute has recently adopted the ISQC 1 "Quality Control for Firms that perform Audits and Reviews of Historical Financial Information and Other Assurance and Related Services Engagements". Communication in this regard was made to all practicing members vide DPSC&E Circular No. 2 dated February 6, 2008. ISQC 1 will become mandatory for all audit firms conducting audit of listed and public interest entities from accounting periods beginning on or after July 1, 2009 and till that time firms would be encouraged to comply with this standard.

In order to assist the firms in assessing and demonstrating their compliance with ISQC 1, a checklist was developed by the Institute and circulated to all practicing members vide DPSC&E Circular No. 3 dated April 1, 2008. Members were requested to submit the ISQC-1 Self-Assessment Questionnaire by June 30, 2008. The main purpose of this meeting is to guide the members in completing the self assessment questionnaire on ISQC 1, which can be downloaded from ICAP website on the following link:-
