



3. The last date for withdrawal of nomination is Friday, March 13, 2020 till 5:00 p.m.
4. The election shall be held on Tuesday, March 17, 2020 from 9:00 a.m.– 4:30 p.m. at The ICAP House, Clifton, Karachi
5. Trainees interested to vote must adhere to the following guidelines:
 - Each voter shall have four (4) votes
 - Only one vote can be cast in favour of a candidate
 - All 4 votes must be cast
6. Four (4) Candidates securing the highest votes shall be deemed to have been elected.
7. The results shall be announced in the AGM by the Chairman Election Committee or his representatives, in the presence of the contestants or their nominated representatives.
8. The decision of the Election Committee shall be final in the event of any dispute.
