IFAC UPDATE

International Standard on Review Engagements 2400 (Revised)

International Auditing and Assurance Standards Board (IAASB) has developed and approved International Standard on Review Engagements 2400 (Revised): Engagements to Review Historical Financial Statements. It deals with the practitioner's responsibilities when engaged to perform a review of historical financial statements, when the practitioner is not the auditor of the entity's financial statements, and the form and content of the practitioner's report on the financial statements. The revised standard is effective for reviews of financial statements for periods ending on or after December 31, 2013.

IASB UPDATE

New IFRS for SMEs Training Modules

The IFRS Foundation Education Initiative has developed training modules for Section 27 'Impairment of Assets' and Section 34 'Specialised Activities' of the IFRS for SMEs. The Education Initiative is developing 35 standalone training modules-one for each section the International Financial Reporting Standard (IFRS) for Small and Medium-sized Entities (SMEs). Currently, 31 modules are available.

IASB Decides on Targeted Re-exposure of Insurance Proposals

The IASB has announced that it will re-expose its proposals on accounting for insurance contracts, however, it will do so with targeted questions. Although the deliberations on the project are not complete the IASB believes re-exposing the proposals will contribute to reducing uncertainty in the market. The targeted questions in the new Exposure Draft will relate to proposed requirements for:

- a. treatment of participating contracts
- b. presentation of premiums in the statement of comprehensive income
- c. treatment of the unearned profit in an insurance contract
- d. presenting, in other comprehensive income, the effect of changes in the discount rate

- e. used to measure the insurance contract liability; and
- f. the approach to transition.

Staff Draft of the General Hedge Accounting Section of IFRS 9

The IASB has published on its website a staff draft of the general hedge accounting section of IFRS 9 'Financial Instruments'. The staff draft is based on the proposals in Exposure Draft ED/2010/13 'Hedge Accounting' published in December 2010 and the tentative decisions the IASB has made during its redeliberations of the Exposure Draft. The staff draft is the result of the re-deliberations of the IASB. The purpose of a staff draft, which is not an official due process document, is to illustrate the IASB's position while at the same time enabling constituents to familiarise themselves with the document.

When finalised, the proposals will become part of IFRS 9: Financial Instruments and will form the section on hedge accounting. They will replace the corresponding requirements in IAS 39: Financial Instruments: Recognition and Measurement, except for the section on portfolio hedge accounting for interest rate risk as noted below.
