Dublic sector "Procurement" whether, is on the basis of Public Fund or funds/ loans by WB, IDA, EBRD, IDB or any other donor, commercial institution is governed by the public procurement rules or the guidelines issued by such institutions. These rules or the guidelines contained the basis for managing procurement, different methods under different circumstances and contracts formulation. How a public procurement may be completed after adhering the certain principles of procurements i.e. transparency, fairness, competition, economy of scale, efficiency and value for money. Evidently, laws sometime are inclusive, with high level of detail; on occasion it insurances only the essentials, depending on further rules, regulations, guidelines and manuals, which might be different but never circumvent the basic principles of procurements?

Keeping in view the significance and relevance of the topic for the members in industry, profession, academia, consulting etc, the CPD Committee Islamabad/Rawalpindi of the Institute of Chartered Accountants of Pakistan has organized important webinar on "Procurement" through Zoom and live on ICAP Face Book page on Monday February 15, 2021 from 4:00pm to 6:00pm.

The webinar started with welcome note by Mr. JehanZeb Amin (FCA), Member Northern Regional Committee (NRC) & Chairman CPD Committee Islamabad/Rawalpindi. The Keynote Speaker for the webinar was Mr. Kashif Mushtaq, Head of Law& Procurement, Punjab Safe Cities Authority, Lahore. Mr. Kashif is an expert of Law and procurement matters with over 20 years of experience of conducting cases, legal acumen, planning, making and acquisitions. His LLM is with thesis on

procurement "concept and advantages". He is author of a Book Titled "Manual of Procurement Laws, Comparison and Commentary" (One of its kind script on Procurement in Pakistan). He is a specialist Trainer, for Capacity Building on Procurement and an expert to seek guidance on completing procurement related administrative tasks as well as to maintain organized approach to Law & procurement along incorporating evaluation and analysis to identify beneficial investments.

Mr. Kashif Mushtaq, delivered presentation on Procurement. He expressed the Principle of Procurement, Laws, Conceptual of Procurement, Basic Ideas of procurement, Public Procurement, Principles of Procurement, Principles of public Procurements, Heads of Procurement (definitions), Kinds of Procurements, Procurement rules, Rules and Regulations of Procurement and Alternative method of Procurement etc.

The Learned Speaker outlined that procurement laws and regulations primarily deal with Employees' benefits law i.e. gratuity/ provident fund, social public procurement planning, necessity requirements, budget provision, strategy development, method selection, documents preparation and advertisement, bid submission, evaluation and selection, and contract are the arenas to know for a worthy & efficacious procurement. He also outlined that deviancy from such public procurement rules or guidelines needs explanation and authorization from a designated authority before the process is agreed otherwise such procurement shall be termed as mis-procurement and invite the accountability. Public servants, procurement consultants, and others involved in the public procurement process, are the guys who always face investigations, inquiries and trials therefore, all those who wants to be an expert in procurement should know all such prevailing laws and guidelines on procurement to save the public exchequer and precious time of the institution.

The Presentation was very interactive. Webinar was very well attended by ICAP members/ Students and Non Members Through ICAP Zoom and Face book page live. The participants showed great interest and raised varies questions which was answered by the worthy speaker.

## Setting New Boundaries

I was raised in a family where working women were rare. However, with my family's encouragement, I chose commerce at a time when medicine was considered the first-choice profession for women. Even my father initially was skeptical of my entrance into a mandeminated profession. However, his pride on my observement as the first woman chartered accountant of the Zubert family, has been a hallmark motory for me.

As one of the very few women in the CA profession, during my four years profession, during my four years professional training at Ford Rhodes Robson Morrow, I felt fike I had to consistently work exists head to ofter my best performance in the fear of losing opportunities. After hearly a decade of working and excelling in my career, I resigned as the Executive Vice President in First Women Back in 2004. One of the male reasons was the pressure of "balencing" both professional and domestic responsibilities at thottom.

I obtained a practicing license and continued freelancing at a time when work from home was a sere phenomenous tater, I joined hands with a few likemisded women and founded the first allwomen-led. CA practicing firm in Pakistan under the name Usraei & Co. Chestered Accountants (UCO):

In my experience, many women with betiliated enterpersourch's elitibles are unable to sustain businesses for long due to lack of financial know-how. Part of our work includes equipping them with the trievant skillert that can encourage them to explore alternative opportunities thereby griving them greater control over the forms of their work.

A huge barrier women face in working are pressing family commitments, to my firm, I introduced the concept of working from home way back in 2013. This is in line with my belief that a workplace policy should equip women at work with facilities that ease the social burden of their gender.

These kind of initiatives not only uplift women who have been excluded from the woodenee, but also privide support to small and medium-steed enterprises (SMIs). Before COVID, these words were also, srefficient and unattainable. Now, the world is relying and functioning entirely on the

I have also been bestowed with the honour of being elected as the first woman Council Member at ICAP, with unanimous support of all members in 2012, and in 2019, was elected as the first woman Vice President (NP). This was a very challenging role and ecquied high-stake decision-making and multiple responsibilities.

Currenty, my professional focus is on two aspects, first, to promote women's participation in our professional aphees, and second, to work for the uplit of the said and medium practices (SMPs) for support SMEs in Pakistain. 



## SECP issues draft amendments to the Companies (Distribution of Dividends) Regulations, 2017

The Securities & Exchange Commission of Pakistan (SECP) vide S.R.O 229 (I)/ 2021 (dated February 18, 2021) issued draft amendments to the Companies (Distribution of Dividends) Regulations, 2017 for public comments.

The draft amendments propose to amend the period for making payment of cash dividend to three working days (currently fifteen working days) from the date of its approval by the:

- (i) Shareholders in general meeting, in case of final dividend: and
- (ii) The board of directors, in case of interim dividend.

- At least one director should have management or business experience of at least five years at a senior level;
- At least one director shall have experience and knowledge in the field of banking, non-banking finance companies, accounting and finance, law, internal audit or any other field ancillary to the capital market or financial market; and
- Omission of the requirement for promoters or sponsors or substantial shareholders of credit rating company to have special knowledge of matters which the company may have to deal with as a credit rating company.

- At least one director shall have experience and knowledge in the field of banking, non-banking finance companies, accounting and finance, law, internal audit or any other field ancillary to the capital market or financial market.

## SECP issues draft amendments to the Share Registrars and Ballotters Regulations, 2017

SECP vide S.R.O. 261 (I)/2021 (dated February 23, 2021) issued draft amendments to the Share Registrars and Ballotters Regulations, 2017 for public comments. The draft amendments mainly propose the following:

 Share registrar registered under these regulations shall only provide services to listed companies;

- In regulation 4, eligibility condition for license proposed to be amended from 3 million minimum paid up capital to minimum net worth of Rs. 10 million;
- The persons who are already licensed under the regulations, shall enhance, if required, their net worth to Rs. 10 million till June 30, 2023;
- Omission of clause f, g and h in Regulation 6;
- Requirement to apply to Commission for renewal of licence proposed to be amended from 'at least two months prior to expiry' to 'at least one month prior to expiry';
- Develop and implement complaint redress policy and take adequate steps for resolution of the complaints;
- Addition of new clauses in regulation 10 relating to independent director, independent auditor, data backup and business continuity plan;
- Addition of a new regulation 15A relating to relaxations from the requirement of these regulations; and
- Few substitutions are made in Annexure-1 of the regulations to include requirement of:
  - Financial soundness and integrity;
  - Educational or other qualification or experience;
  - Competency; and
  - Integrity, honesty and reputation

## SECP issues Securities and Exchange Commission (Reinsurance Brokers) Regulations, 2021

SECP vide S.R.O. 281 (I)/2021 (dated March 04, 2021) issued Securities and Exchange Commission (Reinsurance Brokers) Regulations, 2021. The regulations provide a regulatory framework for establishment and operations of reinsurance brokers and mainly cover the following:

- Requirements for registration of reinsurance broker;
- Obligations and functions of reinsurance broker;
- Capital and statutory deposit requirements;
- Maintenance of books of account and records;
- Fitness and propriety requirements for the Chief Executive and Directors of Reinsurance Brokers;

- Disciplinary proceeding;
- Professional indemnity insurance; and
- List of rating agencies.

#### **SECP issues Modaraba Regulations, 2021**

SECP vide S.R.O. 284 (I)/2021 (dated March 05, 2021) issued Modaraba Regulations, 2021. The regulations provide requirements relating to operations of a Modaraba in the following areas:

- Maximum exposure of a modaraba to a person or group;
- Exposure limits of a modaraba in capital market;
- Minimum conditions for providing finance;
- Linkage between equity of the customer and total exposure from financial institutions;
- Financial indicators of the borrowers;
- Margin against finance;
- Regulations for housing finance for individual;
- Classification and provisioning for non-performing assets;
- Resource mobilization through certificate of musharakah;
- Requirement to maintain capital adequacy ratio; and
- Fit and proper criteria.

## **How Interruptions Can Make Meetings More Inclusive**

nterrupting is controversial. After all, it can make people feel disrespected. But when done skillfully, it can disrupt group norms and bring out reserved voices. Many leaders today find themselves struggling to perform in high-pressure (and these days, usually virtual) meetings, either because their performance anxiety causes a heightened level of fear and paralysis, or because they end up having to compete with bosses and coworkers who overtalk and take up more than their fair share of space in the room. Still others work valiantly to insert themselves but are passed over or rendered invisible or silent because of implicit bias or exclusive group norms. Whatever the cause, for both leaders who struggle to be heard and bystanders who want to hear more from quiet colleagues, the skill of interrupting can be helpful to practice to disrupt group norms and bring out reserved voices.

The following tips can help you skillfully interrupt and bring yourself and others forward.

**Start by noticing** Observe the conversational dynamics and patterns in the room. Who's talking a lot and who isn't? Tune into self-awareness to notice your own contributions. Are you holding back? Are you oversharing? Evaluate how much psychological safety exists in the meeting and consider the topics that aren't being voiced aloud. **Practice speaking up early** If your tendency is to hold back, try speaking up in the first 30% of the meeting. When we take a risk and use our voice early — even in a simple act of noticing and naming — we can interrupt our brain's proven fear-

based amygdala response, making it easier to speak up later in the meeting, to speaking up and make it easier to contribute when the stakes are higher. Pause the action skillfully stress the importance of interrupting micro aggressions in real time with a simple phrase to pause the action while putting the other person at ease. Witnesses can interrupt by stating a helpful intention: "Can we pause to discuss something that was just said? I'm sure you didn't mean anything by it, but..." Be willing to get it wrong In coaching, the skill of blurting helps give permission to be clumsy, messy, and human in our attempt to speak our truth. Blurting asks that we be willing to not know the right words or have the perfect way to name what we need to say. Blurt by using "I" statements to ground your observations in your own experience. **Design** practices for interruption as a team interrupting successfully as a team requires building a group norm of doing it with skill and respect and to not take it personally. Start a discussion to make your team aware of these dynamics.

In the practice of interrupting, clumsiness and awkwardness are a sign that it's working. Over time, you'll find it easier to insert yourself in spaces and make it safe for others to do the same. You'll become more adept at finding the right moment to interrupt with fluidity and humility, and the systems and spaces you're a part of may even come to welcome the interruption.
