



Professional Misconduct

Findings and Decision of the Council under Section 20I of the Chartered Accountants Ordinance, 1961

It was noted that a practicing member of the Institute conducted the audit of financial statements of a Public Interest Company for the year ended June 30, 2016, despite the fact that his firm did not have satisfactory Quality Control Review (QCR) rating under the QCR Program of the Institute. The member has failed to comply with the requirements of the Code of Ethics for Chartered Accountants by providing professional services in respect of the assignment which he was not eligible and competent to perform.

The Council after considering the report of the Investigation Committee also provided opportunities for hearings to the member which he did not avail.

In view of the above, after considering the report of the Investigation Committee and the information and evidence available on record, the Council decided to hold the member guilty of professional misconduct under:

- Clause (3) of Part 4 of Schedule I of the Chartered Accountants Ordinance, 1961 for not complying with the fundamental principles stated in Paragraphs 100.5(c) (Professional Competence & Due Care) and 100.5(e) (Professional Behavior) of the Code of Ethics for Chartered Accountants (April 28, 2015) contained in Directive 6.04 of the Institute; and
- Clause (5) of Part 4 of Schedule I of the Chartered Accountants Ordinance, 1961 for being guilty of an act or default discreditable to a member of the Institute.

The Council decided to reprimand the member under Section 20D of the Chartered Accountants Ordinance, 1961.

ICAP issues Exposure draft of Accounting Standard Non-Going Concern Basis of Accounting for stakeholder consultation

The Accounting Standards Board (ASB), through Circular 3 (dated August 05, 2022), has issued the Exposure Draft (ED) of Accounting Standard 'Non-Going Concern Basis of Accounting', for stakeholder consultation.

This Accounting Standard has been developed due to the reason that the Financial Reporting Standards applicable in Pakistan (including International Financial Reporting Standards) do not provide specific guidance for the Accounting and Financial Reporting for preparation of Financial Statements by a non-going concern entity. This leads to varied views, Accounting Treatments and Presentations, resultantly impacting the comparability and relevance of the Financial Statements of non-going concern entities.

ASB has developed the Accounting Standard with the objectives of providing Accounting and Financial Reporting Framework for non-going concern entities and to ensure that relevant and useful Financial Information is provided to the users of the Financial Statements. ASB firmly believes in the broad consensus among the stakeholders involved in the development, adoption and implementation of the Accounting Standards. Local Corporate Regulatory Framework

SECP issues amendments to the Code of Corporate Governance for Insurers, 2016

The Securities and Exchange Commission of Pakistan (SECP), through S.R.O. 1013(I)/2022 (dated July 05, 2022), issued amendments to the Code of Corporate Governance for Insurers, 2016. The amendments mainly relate to the following:

- Substitution of the expression 'Code of Corporate Governance, 2012', by the expression 'Listed Companies (Code of Corporate Governance) Regulations, 2019';
- Mandatory requirement for the Board of Directors of Insurance Companies to include one third of Directors as Independent Directors;
- Addition of requirement to have at least one female Director in Board of Directors:
- Few provisos inserted in clause (iii) after clause(a);
- Substitution of the expression 'Companies Ordinance, 1984' by the expression 'Companies Act, 2017' shall be substituted: and
- Addition of new clauses in relation to: Related party transactions; Director's Training; Trading by Employees Offences and Penalties; and Outsourcing of Internal Audit Function.

SECP, through S.R.O. 1014\(I)/2022 (dated July 05, 2022), has notified amendments to the Unit Linked Product and Fund Rules, 2015. SECP issues amendments to Insurance Rules, 2017

SECP, vide S.R.O. 1513(I)/2022 (dated August 16, 2022), made amendments to the Insurance Rules, 2017.

The changes relate to introduction of a registration regime for Digital-only insurers and Micro-Insurers. The registration requirements have been designed to reduce barriers to entry, in terms of minimum paid up Capital and Solvency requirements. The minimum paid up Capital Requirements have been set at Rs.100 million for Non-Life Digital-only Business and Rs.250 Million for Life Digital-only Business, whereas for Non-Life and Life Micro-Insurers, the Capital requirements have been set at Rs.80 million and Rs.150 million, respectively.

SECP notifies condition of investment by Modaraba in Real Estate

SECP, through S.R.O. 1546(I)/2022 (dated August 15, 2022), notified that Modaraba can hold, deal or trade in Real Estate Projects, subject to the following conditions.

- Investments shall be made only in assets recognized by Development Authorities; and
- The purpose of investment can be to develop properties for Rental or Development or mix (both Rental and Development) Projects.



Further, in case of a specific-purpose Modaraba following additional conditions also apply:

- At least two Directors of the Modaraba Company shall have a minimum of five (5) years of experience of dealing with the real estate projects;
- A valuation report from the independent valuer shall be obtained; and
- The prospectus of the Modaraba shall, contain required information

SECP issues amendments to Modaraba Regulations, 2021

SECP, through S.R.O. 1547(I)/2022 (dated August 15, 2022), has brought in changes in the Modaraba Regulations, 2021. The amendments mainly relate to:

- Transitional provisions for Modarabas to comply with the minimum equity requirement;
- Increased the per party house Finance limit;
- Allowing modarabas to engage in real-estate business;
- Simplifying the requirements for reserve funds following the withdrawal of tax incentives;
- Aligning the time period for filling casual vacancies with the Companies Act, 2017; and
- Creating an enabling provision to impose penalties for violations of provisions of the Modaraba Regulations, 202*1.
