



FATF Removed Pakistan from Grey List



The Financial Action Task Force (FATF) has removed Pakistan from the list of countries under increased monitoring commonly known as Grey List.

Pakistan has successfully completed a combined 34 items Action Plan, which was recognized by FATF. This was the result of the untiring efforts from all the relevant authorities of Pakistan. ICAP, being a core member of the Government Working Group, played a vital role in ensuring compliance of the Anti – Money Laundering Regulations. It is pertinent to mention that ICAP was the pioneer in establishing the AML/CFT Regime within the Designated Non-Finance Businesses & Professions (DNFBPs) sector of Pakistan. Practicing Members of ICAP have also worked hard collectively with their Regulator (ICAP) to ensure compliance of the Regulations within their Firms.

ICAP issues draft Accounting Technical Releases (Revised) for comments

The Accounting Standards Board (ASB) of the Institute of Chartered Accountants of Pakistan, through Circular 05/2022 (dated September 28, 2022) issued the draft Accounting Technical Releases (Revised), for stakeholders' consultation.

ASB has carried out a comprehensive review of the extant Accounting Technical Releases (TRs) with objective to:

- Update the TRs in accordance with the changed accounting and regulatory requirements;
- Improve the structure and drafting convention of the TRs: and
- Propose withdrawal of TRs (if required) in view of new guidances under the IFRS Accounting Standards.

Based on its review and deliberations, ASB has proposed revisions and structural improvements in TR 5, TR 6, TR 8, TR 22 and TR 32. ASB has also decided the withdrawal of TR 27 and TR 29. Comments and feedback can be shared by November 15, 2022.

SECP issues amendments in the Securities Exchanges (Licensing and Operations) Regulations, 2016

The Securities and Exchange Commission of Pakistan (SECP), through S.R.O. 1896 (1)/ 2022 (dated October 10, 2022) and 1914(I)/2022 (date October 14, 2022) issued

amendments to the Securities Exchanges (Licensing and Operations) Regulations, 2016. The amendments include changes in schedule III and insertion of new regulation 3A, Form A1 and new subclause (aab) in sub-regulation (1) regulation 4.

SECP issues amendments in the Futures Brokers (Licensing and Operations) Regulations 2018

SECP through S.R.O. 1912(I)/2022 (dated October 14, 2022), issued amendments to the Futures Brokers (Licensing and Operations) Regulations 2018. The amendments mainly relate to the following:

- Omission of clauses (e) and (k) in in sub-regulation (1), regulation 2;
- Insertion of provisos in regulation 4, sub regulation (1);
- Minimum net worth requirement has been reduced from Rs. 20 million to 10 million and expression paid up capital is omitted;
- Time period for future exchange to visit future broker premises to ensure requirements mentioned in regulation 8, in sub-regulation (4) have been increased from 15 days to three months;
- Renewal of licence shall be applied by the future broker before thirty (30) days prior to the date of expiry of its licence;
- The futures exchange shall conduct periodic visit/inspection of the branches of brokers on basis of risk-based inspection plan to ensure its compliance with the regulatory framework;
- Substitution of the word "biannual" for the word "quarterly" in clause (e) sub-regulation (10), regulation 16;
- Substitution in regulation 23 'Receipt of customer money' - A futures broker shall not receive customer money in its own name or hold customer assets for whatsoever purpose; and
- Changes in Annexure A, B and C.

IESBA publication on relevance and applicability of the IESBA code in combatting greenwashing

The International Ethics Standards Board for Accountants (IESBA) on October 21, 2022 has issued a Questions &

Answers (Q&A) publication, Ethics Considerations in Sustainability Reporting, Including Guidance to Address Concerns about Greenwashing. The publication highlights the relevance and applicability of the IESBA Code to ethics-related challenges in the context of sustainability reporting and assurance, especially circumstances involving misleading or false sustainability information (i.e., "greenwashing").

The publication highlights key provisions in the Code that apply in preparing and presenting sustainability information. It emphasizes the professional accountant's obligation to be straightforward and honest and refrain from being associated with information that is misleading or false, including in situations where they might experience pressure to do so.

IESBA-JICPA non-authoritative publication on application of IESBA Code to Technology-Related Scenarios

The IESBA's Technology Working Group jointly with the Japanese Institute of Certified Public Accountants (JICPA) has issued the non-authoritative publication 'Ethical Leadership in a Digital Era: Applying the IESBA Code to Selected Technology-Related Scenarios'.

This publication provides seven hypothetical scenarios to illustrate how accountants can navigate practical issues in ethical leadership when using or implementing technology. Each scenario highlights the application of specific requirements and guidance in the IESBA Code, in particular those related to compliance with the fundamental principles of ethics, and auditor independence.

IESBA publishes Staff Alert, The Ukraine Conflict: Key Ethics and Independence Considerations

The IESBA published the Staff Alert, The Ukraine Conflict: Key Ethics and Independence Considerations on October 03, 2022. The publication draws the attention of



professional accountants in business (PAIBs) and professional accountants in public practice (PAPPs), including firms, to a number of important provisions in the International Code of Ethics for Professional Accountants (including International Independence Standards) (the IESBA Code) with which they must comply in carrying out their work as they navigate the unprecedented challenges and risks arising from the Russia-Ukraine war.

The Staff Alert highlights the ethical implications arising from the wide-ranging economic sanctions many jurisdictions have imposed on Russia and certain Russian entities and individuals as well as Belarus, and the related ethical responsibilities of PAIBs and PAPPs under the Code. It also highlights:

- Key ethics considerations for PAIBs in relation to the preparation and presentation of information, especially as regards accounting for and disclosing the impact of the Ukraine conflict on their employing organizations' business; and
- Key ethics considerations for PAPPs in relation to client and engagement acceptance, and in the context of audits of financial statements, key independence considerations relating to overdue fees and the Code's prohibition against assuming management responsibility.

IAASB opens public consultation for revised ISA 500 'Audit Evidence'

The IAASB on October 24, 2022 has issued exposure draft for public comments on the proposed changes in one of its fundamental standards, International Standard on Auditing (ISA) 500, Audit Evidence. The current ISA 500 addresses an auditor's responsibility to design and perform audit procedures to obtain sufficient appropriate evidence to draw reasonable conclusions on which to base the auditor's opinion.

Through the proposed changes to ISA 500 (Revised) the IAASB intends to:

 Clarify ISA 500's purpose and scope and explain its relationship with other standards;

- Provide a principles-based approach to considering and making judgments about information intended to be used as audit evidence and evaluating whether sufficient appropriate audit evidence has been obtained;
- Modernize ISA 500 to be adaptable to the current business and audit environment, while considering scalability for different circumstances, including the entity and the auditor's use of technology, such as automated tools and techniques; and
- Emphasize the role of professional skepticism when making judgments about information intended to be used as audit evidence and evaluating the audit evidence obtained.

The proposed ISA 500 (Revised), also provides a "reference framework" for auditors when making judgments about audit evidence throughout the audit.
