## CA Pakistan Overseas Convention 2023

#### "Seizing Opportunities from Economic Crisis"



The Overseas Coordination Committee of ICAP has organized the first all-virtual CA Pakistan Overseas Convention 2023 on 13th January 2023. The convention witnessed outstanding participation being one of the biggest virtually engaged events in ICAP's history with over 350,000 individuals involved on social media.

The event hosted 23 dignitaries from across the globe, who spoke on the theme of "Seizing Opportunities from Economic Crisis" and enlightened the audience with their knowledge and insights. The audience benefited from the valuable knowledge sharing by experts giving a 360-degree perspective to the theme of the convention and having the opportunity to gain insights from experts of high repute from across the globe possessing diverse experiences with immense knowledge. Over the virtual platform, the convention engaged practiced economists, policymakers, proficient finance professionals, business thought leaders, collaborating partners, corporate executives, start-up architects, and multifaceted individuals from across the globe.

The overseas representatives of ICAP welcomed the attendees of the convention, while highlighting the International Footprint of the institute, through video messages.

In opening remarks, an overview of the convention was presented and emphasis was made on how multiple opportunities could be extracted from the economic crises by Ms. Hina Usmani, Chairperson OCC. She highlighted the three key components of the convention - understanding the economic crisis, analysing the impact on people, and considering a sustainability viewpoint - and thanked the expert





speakers from multiple geographies for their participation. She also expressed her gratitude to the ICAP leadership.

Mr. Ashfaq Yousuf Tola, highlighted the importance of recognizing opportunities during periods of economic stress. He discussed that the economy of Pakistan is facing a difficult situation due to the global economic situation, with external imbalances leading to overspending and a low projected GDP growth of 1.7%. The country is in an IMF program and has agreed to certain conditions, but this has become difficult to fulfil due to floods and imbalances in imports and exports. The government cannot borrow from the State Bank of Pakistan, which has become autonomous, and this is a major blow to the country's economy.





Mr. Salman Haider discussed the two major current crises: the pandemic and the war in Ukraine, and the increasing concern about the division of the global economy into geopolitical partnerships and their effects on the pandemic and war.

Mr. Moazzam A. Shah discussed four areas for businesses to address in order to navigate successfully through an economic crisis: debt, decision-making, workforce management, and digital transformation. Further, the panel discussion on "Seizing the Prospects of a New Economy" discussed the opportunities in the retail sector, digitalization, automation, ESG, and the transformation of the energy sector.

Mr. Muhammad Aurangzeb, President HBL, attended the convention at ICAP Karachi, spoke on the importance of strategic innovation to help businesses unlock a new source of growth, citing Winston Churchill's quote "never let a good crisis go to waste". He highlighted Pakistan's resilience and the need for disruptive innovation, especially for the growth of the agriculture sector.

The convention culminated with the inauguration of the ASEAN Chapter of ICAP Members as the first regional chapter covering 10 countries in South East Asia.

Her Excellency Ms. Amna Baloch, Pakistan's High Commissioner to the Republic of Kuala Lumpur, Malaysia, discussed the importance of recovery programs such as quantitative easing and transfer payments to individuals to keep young people connected to meaningful work.

Mr. Saqib Baig highlighted the need for recovery efforts to both reflect current drivers of economic growth and to take advantage of the process of "creative destruction" to accelerate structural shifts towards a stronger and more sustainable economic future. He further discussed the importance of people skills development during an economic downturn.

A panel discussion on "Insights on People Skill Development during an Economic Downturn" was moderated by Mr. Yaqoob Suttar and included Mr. Noman Ali, Mr. Sohail Raza, Mr. Asher Noor, and Ms. Chamila Cooray. They discussed how people skill development is being handled or addressed in different parts of the world, and the specific skills needed to be developed or acquired going forward.

Mr. Omer Mustafa Ansari discussed resilience for sustainability amid a worldwide economic downturn, highlighting the biggest challenges globally and in Pakistan, such as climate change, plastic pollution, resource depletion, food security, and supply chain for commodities. He recommended measures for Pakistan's economy as a way forward, and demonstrated how Islamic finance and economics could help achieve sustainability. Ms. Asmaa Resmouki, President IFAC, spoke on "Leadership for Sustainability in Crisis", emphasizing that the next decade will be the most important in human history due to global economic, environmental, pandemic, and war crises. She noted that our profession has a key role to play in the face of this enormous challenge and that decisive and thoughtful action is necessary.

The last panel discussion, moderated by Mr. Farrukh Rehman, focused on "Sustainability and Resilience in Organizations During Times of Crisis". Panelists included Ms. Susan Rossney, Mr. Ahmed Mukhtar, and Dr. Hadi Shahid. They discussed how our attempts to become sustainable have been replaced by our need to protect our





core functions and build resilience, as well as the impact of the economic crisis on people and the work environment. They concluded that the way out is only possible when complementary efforts are made to support each other's decisions, leading to a ripple effect that will allow the economy to take off again.

Mr. Asad Feroze eloquently summed up the key takeaways of the convention, while Mr. Abu Talib Haideri thanked the audience and the entire team for their dedication and commitment to the success of this convention. The captivating hosting of our MOCs Mr. Imran Ahmad, Ms. Shafaq Fauzil Azim, Mr. Ali Bilal, and Ms. Anam Nadia Rehman and the incredible efforts of ICAP team were instrumental in making this event a success. Overall, the ICAP Convention provided a comprehensive analysis of the current economic climate and provided useful strategies for navigating through difficult times and people skills development to help the economy survive and thrive during a crisis, as well as the need for timely and decisive action to address the major challenges faced globally by recognizing new opportunities, utilizing digital strategies, and experimenting with innovative ideas, businesses can create a successful path forward during the crisis. These conversations and insights presented during the session provided valuable learning opportunities for attendees.

The Council recorded its appreciation for the successful CA Pakistan Overseas Convention 2023 held by the Overseas Coordination Committee in it's 364th Council meeting.

## 17th Trainees' Induction Fair



The Institute of Chartered Accountants of Pakistan (ICAP) successfully organized the 17th Trainees' Induction Fair at its offices in Karachi, Lahore, Islamabad, Multan, Faisalabad, Gujranwala, and Peshawar on January 17, 2023. The objective of this event was to guide CAF-qualified students on the benefits of joining Training Organizations (TOs) as soon as possible. Over 300 students attended the fair, while around 100 TOs set up their stalls.

The event began with the master of ceremony, Mr. Anayat Ullah Khan, Senior Manager - Education & Training, followed by recitation from the Holy Quran and the National Anthem. Mr. Abu Talib Haideri, Secretary of ICAP, delivered his welcome address. He congratulated the students on completing their first milestone by passing the CAF Level. He urged that there is no point in waiting endlessly in pursuit of training in larger TOs and suggested that students should choose the best available options and start their training sooner rather than later. He advised the students to stick to hard work, dedication, and commitment.

The first panel discussion was on "How much a Training Organization Matters in a Professional Career?". The moderator, Ms. Sabahat Batool, ACA, began the discussion by highlighting the importance of Mandatory Training in the CA profession. The panel consisted of Mr. Muhammad Ahsan Ali, ACA, Mr. Muhammad Mehran-Ur-Rashid, ACA, Mr. Muhammad Soban Saleem, ACA, and Mr. Osama Ahmed, ACA. All the panelists shared their opinions about the expectations of TOs from fresh trainees. The discussion revolved around the development of leadership skills, people management skills, diverse culture and work norms, and learning in Small and Medium-sized Practices. All the panelists were of the opinion that students should start their mandatory practical training as soon as possible, so they can complete their qualification in the minimum possible time.

Mr. Husnain R. Badami, Vice President ICAP advised the students to be responsible and reliable, to create a network, to grab opportunities, and to work on time management. He also emphasized that they should never neglect their studies during their training. He also guided the students that a positive attitude plays a vital role in every situation.

Mr. Ahmad Abdullah, CEO of the SAY Global Foundation, began the session on mental health. He shared his personal journey of coping with mental health trauma. Dr. Junaid Rasool, Director and Member of the Board of Directors of the SAY Global Foundation, added insights on how to identify sources of stress and manage them. He shared that in any situation, there are three options: to leave the situation, to tolerate it with resentment, or to tolerate it without resentment. He suggested that the last option is the most desirable. He also provided tips for time management to overcome undue stress.

Mr. Saifullah, Vice President ICAP also guided the young students and advised that time management is crucial when undergoing mandatory training. He encouraged

#### **Professional Misconduct**

#### Findings and Decision of the Council under Section 201 of the Chartered Accountants Ordinance, 1961

It was noted that a practicing member of the Institute, Mr. Sikander Lalani, FCA [R-1360] was engaged in other occupation while being a practicing member of the Institute which results in professional misconduct under the provisions of the Chartered Accountants Ordinance, 1961 and Chartered Accountants Bye-Laws, 1983. Further, during the course of the above inquiry, the member did not provide information which was required by the Institute in relation to the proceedings.

The Council after considering the report of the Investigation Committee, provided opportunities of hearings to the member which he did not avail.

In view of the above and after considering the report of the Investigation Committee and the information and evidence available on record, the Council decided to hold Mr. Sikander Lalani, FCA [R-1360] guilty of professional misconduct under:

- Clause (10) of Part 1 of Schedule I of the Chartered Accountants Ordinance, 1961 for engaging in any business or occupation other than the profession of Chartered Accountants without permission of the Council so to engage;
- Clause (3) of Part 4 of Schedule I of the Chartered Accountants Ordinance, 1961 for not supplying the information called for by the Institute and for not complying with the fundamental principle stated in Paragraph 100.5(e) (Professional Behavior) of the Code of Ethics for Chartered Accountants (April, 2015) contained in Directive 6.04 of the Institute; and
- Clause (6) of Part 4 of Schedule I of the Chartered Accountants Ordinance, 1961 for contravening the provision of the Chartered Accountants Bye Laws, 1983.

The Council decided to reprimand the member under Section 20D of the Chartered Accountants Ordinance, 1961.

#### ICAP issues Exposure Draft of Accounting Standard 'Financial Statements Disclosures of Zakat Received by an Entity'

ICAP through Circular No. 1/ 2023 (dated January 02, 2023) has issued Exposure Draft of Accounting Standard "Financial Statements Disclosures of Zakat Received by an Entity", along with its Basis for Conclusions, for members comments and feedback by February 15, 2023.

Accounting Standard Board (ASB) of ICAP, in consideration of the following aspects has developed this accounting standard:

- Significant amounts of zakat are received and utilized by Not-for-Profit Organizations in Pakistan;
- The contribution of zakat includes many contributors/ donors;
- The utilization of zakat involves various activities and beneficiaries; and
- The financial reporting standards as applicable in Pakistan (including Accounting Standard for Notfor-Profit Organizations) do not provide specific disclosures for zakat received and utilized by an entity.

The proposed standard outlines specific disclosures in the financial statements to improve the transparency and accountability of the entity's receipt and utilization of zakat

## SECP issues amendments on 7th Schedule of Companies Act, 2017

Securities and Exchange Commission of Pakatan (SECP) through S.R.O. 2308 (I)/2022 (dated December 22, 2022) issued amendments in the Seventh Schedule to the Companies Act, 2017. The amendments include insertion of following proviso in Item No VII, after serial No. (2) of 7th Schedule:

"Provided that the Commission shall approve fee to be charged from respective Federal

and Provincial government departments, organizations and authorities from time to time".

## SECP issues 'Guidelines for Offering Islamic Financial Services, 2023'

The SECP has issued 'Guidelines for Offering Islamic Financial Services, 2023', which cover all its regulated sectors. The guidelines are framed to facilitate growth of Shariah-compliant financial products in the financial services market regulated by the Commission, which include Islamic capital markets, Takaful, Modarabas, NBFCs, pension and private funds, REITs, and so on. The guidelines cover key principles for the conduct of Shariah-compliant operations by persons offering Islamic financial services, conversion of conventional financial institutions into Islamic financial institutions



and the foundational principles for developing cohesive Shariah governance within Islamic financial institutions. It also introduces the concept of "Islamic windows" in all regulated sectors.

#### IASB issues exposure draft on International Tax Reform

International Accounting Standards Board (IASB) on January 09, 2023 has issued the Exposure Draft (ED) International Tax Reform - Pillar Two Model Rules. The ED proposes amendments to IAS 12, Income Taxes, with an aim to provide temporary relief from accounting for deferred taxes arising from the imminent implementation of the Pillar Two model rules published by the Organization for Economic Co-operation and Development (OECD). The proposed amendments would introduce:

- a temporary exception to the accounting for deferred taxes arising from the implementation of the rules; and
- targeted disclosure requirements for affected companies.

## IAASB opens public consultation on Less Complex Group Audits

The International Auditing and Assurance Standards Board (IAASB) on January 25, 2023, opened the public consultation for a group audit-specific section of the proposed standard for audits of less complex entities (ISA for LCE).

Group audits were not included in the scope of the original Exposure Draft of the ISA for LCE. Based on stakeholder feedback received, the IAASB reconsidered its decision and developed proposals that address audits of less complex groups. With the inclusion of group audits, the IAASB has proposed changes to the Authority of the proposed ISA for LCE and has added proposed section, Part 10, Audits of Group Financial Statements. The Exposure Draft is open for public comment until May 2, 2023.

- Strengthen coordination with the IESBA and other leading standard setters/ regulators to leverage better collective actions in the public interest; and
- Create more agile, innovative ways of working in line with the Monitoring Group's reform vision.

In 2022, the impact of various initiatives taken during the 5-year formation of the CA Women Committee was reviewed to determine the outcome of its core objective of increasing women's intake into the CA profession. To our delight, we noticed a remarkable increase in the annual intake of women in the profession. With the encouragement of ICAP past president, Mr. Naeem Akhter Sheikh, we shared this success story with the International Federation of Accountants (IFAC). We are grateful to IFAC for promptly showcasing the success of female chartered accountants in Pakistan on its Knowledge Gateway under the topic of Developing the Accountancy Profession and highlighting it on their social media pages.

We are proud of this achievement and believe that this publication will lead to regional averages of women participating in the CA profession in the near future.

- Q.1 What you want to suggest to the students of CFAP-6: Audit, Assurance & Related Services?
- Ans Thank you for the opportunity to share my experiences with other students. The following factors contributed to my award of a Certificate of Merit in CFAP-6: Audit, Assurance, and Related Services in Winter 2021:

- Comprehensive coverage of the syllabus and clear understanding of all course content.
- Thorough consultation of ISAs during studies, with brief reference during the exam.
- Attempting all parts of all questions and completing the paper within the allotted time.
- Regular self-studies and practice with mock papers.
- Relating course content to real-world scenarios.
- Effective time management and a healthy study routine.

I hope this information will be beneficial for students in their future studies and exams.

- Q.2 Being a Trainee from a TOoP, how did you get Certificate of Merit in CFAP-6: Audit, Assurance & Related Services?
- Ans It is often believed that only students trained by Training Organizations within Practice (TOiP) have a deeper understanding of Audit and Assurance. However, I received training from a Training Organization outside of Practice (TOOP) and still earned a Certificate of Merit in CFAP-6: Audit, Assurance, and Related Services. Passion for learning and being open to knowledge from all sources is key to success in any field. To deepen understanding, apply acquired knowledge to various scenarios. Combining practical experience with imagination improves comprehension. The Institute of Chartered Accountants of Pakistan's (ICAP) past papers offer real-world scenarios and solutions, which are useful for correcting misconceptions and enhancing understanding of the syllabus.

I improved my knowledge by regularly practicing with past papers, topic-by-topic, and consulting suggested solutions, examiner comments, and marking plans to assess my understanding of each area of the syllabus.

- Q.3 How did you get inducted in SNGPL?
- Ans After passing the CAF exam in Spring 2019, I applied to top firms but despite participating in several interviews, no job offers were received. The pressure of not having secured a training contract was growing. However, I attended the Trainees' Induction Fair organized by the Institute of Chartered Accountants of Pakistan (ICAP) and was impressed by the Sui Northern Gas Pipelines Limited (SNGPL) booth. I submitted my resume and was soon called for an interview and offered a training contract.

Participation in the Trainees' Induction Fair led to my unexpected entry into the industry. I'm grateful for ICAP's initiative in organizing such events, which provide a platform for CAF graduates to connect with Training Organizations.

- Q.4 In which departments you got a chance to work in SNGPL?
- Ans During the first 1.5 years of my training, I was in the Internal Audit department. I then spent the next 1.5 years in the Finance department, gaining expertise in budgeting and inventory management. Now, I'm assigned to the Accounts department. I often seek guidance from my MRS, Mr. Kamran Akram, and ask him to change my department when I feel I have learned all I can and the work has become repetitive. I'm lucky to have a knowledgeable and supportive MRS who guided me throughout my training journey.
- Q.5 What message do you want to give to the students who want to join Training Organizations outside Practice (TOoP)?
- Ans I think industry articles are great for students who want to work in the corporate sector in the future. The market needs more internal audit and financial experts, and working in industry offers ample exposure



and learning in these areas. However, for those who plan to start their own practice, training in a Training Organization within Practice (TOiP) may be the better choice.

In my experience, the work environment in a TOOP/industry is safer, female-friendly, and more relaxed than in TOiPs, where trainees have to visit different clients. The pressure is also much higher in TOiPs. For women who don't plan to continue CA after passing the CAF Level for these reasons, training in TOiPs still provides valuable experience and exposure.

I'm glad I joined SNGPL, an oil and gas company, because gaining experience here is highly valued and opens up job opportunities in the Middle East. My experience has been very positive overall.

- Q.6 What do you feel today that you passed your CFAP and MSA level exams, during your Training?
- Ans I feel proud and accomplished for passing all my exams during my training period and receiving a Certificate of Merit.
