1st CFO Roundtable in Karachi

The CFO Roundtable, an initiative by ICAP's PAIB Committee, provides a vital platform for CFOs to navigate challenges and seize opportunities within the accounting profession. Led by Mr. Samiullah Siddiqui, the committee's role in continuous professional development and advocacy was highlighted in a recent meeting held on November 14, 2023, at Marriot Hotel Karachi.

CFO Roundtable is strategically designed with an aim to address industry challenges and shape the future of finance. The inaugural discussion focused on the Banking Sector, on the topic "CFO Lens-Navigating"

Today's Challenges" with an emphasis on digitization, business ethics, and ESG. Esteemed CFOs from leading banks engaged in a dialogue moderated by Mr. Irfan Awan, CFO Bank of Khyber, covering vital aspects of ESG considerations within the banking sector.

Discussions on ESG explored climate risks, the need for tailored approaches, and the potential for ICAP to bridge gaps between perception and roles. Recommendations included consultation on ESG standards adoption, compulsory governance in financial statements, and ICAP playing a role in standardizing ESG implementation.



















The conversation on digitization delved into CFOs' roles, motivations, and the importance of collaboration between finance and technology teams. Key considerations included aligning digital strategy with business strategy, the role of the Chief Information Officer, and the impact of digitization on financial inclusion and literacy.

Ethical considerations highlighted challenges in reporting and forecasting, the absence of clear

measurement tools, and the critical role of finance professionals in Anti-Money Laundering practices. The importance of meticulous reporting, transparent financial transactions, and the need for a standardized approach to ethics were underscored.

The meeting yielded several actionable items, ranging from advocating for a mandatory framework for ESG disclosures to facilitating the development of ESG frameworks. Plans were also made to invite industry



experts for a Stakeholders Session on ESG, introduce hands-on courses on digitization, and provide guidance on implementing IFRS 9 and ethics, with a special emphasis on AML compliance.

Engaging Q&A




professionals, enriching their understanding of the skills that will shape their future endeavors.





ICAP Updates

Invitation of Comments/Suggestions regarding the manner of conduct of General Meetings of Shareholders

ICAP, on the request of Securities and Exchange Commission of Pakistan, has requested comments from its members on the manner of conduct of General Meetings of shareholders.

SECP has issued a Press Release on November 02, 2023, regarding the establishment of a committee, who is tasked to review how listed companies conduct their shareholder meetings. The Committee include representatives from Institute of Chartered Accountants of Pakistan (ICAP), Pakistan Stock Exchange (PSX), Central Depository Company (CDC), Mutual Funds Association of Pakistan (MUFAP), Pakistan Business Council (PBC), Pakistan Institute of Corporate Governance (PICG), and the CFA Society. The committee's representatives were asked to seek feedback from the members of their organizations/bodies.

Draft Guidance on Accounting for Minimum Taxes and Final Taxes for comments

ICAP has published a draft guidance on 'Accounting for Minimum Taxes and Final Taxes', for feedback through its Circular No. 8/2023.

The draft guidance is aligned with IAS 12, Income Taxes and covers accounting for the following:

- Final Tax (termed so in the Income Tax Ordinance, 2001)
- Minimum Tax paid under section 113 of the Income Tax Ordinance, 2001
- Minimum Tax paid under other than section 113 of the Income Tax Ordinance, 2001.

On finalization of this guidance, the existing TR 27 on IAS 12, Income Taxes will be considered for withdrawal/ revision. Comments on the circular is requested by December 8, 2023.

Compilation of Agenda Decisions - Volume 9 published

The IFRS Foundation has released its ninth Compilation of Agenda Decisions made by the IFRS Interpretations Committee between May 2023 and October 2023.

This Compilation encompasses three specific agenda decisions:

- Premiums Receivable from an Intermediary (related to IFRS 17 Insurance Contracts and IFRS 9 Financial Instruments)
- Homes and Home Loans Provided to Employees
- Guarantee over a Derivative Contract (pertaining to IFRS 9)

The Interpretations Committee collaborates with IASB to ensure uniform application of IFRS Accounting Standards. Queries regarding the application of these standards are reviewed by the Committee, which, after analysis and public consultation, issues an agenda decision if it determines that no new standard-setting project is needed.

Agenda decisions outline the Committee's conclusions and often provide explanatory material illustrating how the relevant principles and requirements in IFRS Accounting Standards relate to the issue discussed.

Webcast for overview of forthcoming IFRS Accounting Standard for subsidiaries

The IASB has released a webcast outlining the upcoming reduced-disclosure 'IFRS Accounting Standard for subsidiaries under parent companies' using IFRS Accounting Standards. The webcast included an overview of the new standard, eligible subsidiaries, benefits for both subsidiaries and parent companies, and its impact on the financial statement's users.

The new Accounting Standard is expected to be issued in the first half of 2024, effective for annual reporting periods beginning on or after January 0, 12027 and early application is permitted.

IASB to publish Exposure Draft Financial Instruments with Characteristics of Equity

IASB has recently published the Exposure Draft 'Financial Instruments with Characteristics of Equity'. The IASB



has proposed amendments to address the existing challenges in companies' financial reporting on financial instruments with characteristics of equity. The proposals in the Exposure Draft would amend IAS 32 Financial Instruments: Presentation, IFRS 7 Financial Instruments: Disclosures, and IAS 1 Presentation of Financial Statements.

The proposals include:

- clarification of the underlying classification principles of IAS 32 to help companies distinguish between financial liabilities and equity;
- disclosures to further explain complexities around instruments that have both financial liability and equity characteristics; and
- presentation requirements for amounts including profit and total comprehensive income - attributable to ordinary shareholders separately from amounts attributable to other holders of equity instruments.

IAASB Updates

New Auditing Standard for Less Complex Entities

On December 6, IAASB has announced to publish a new standard for audits of less complex entities, called ISA for LCE.

Smaller, less complex entities (LCEs) make crucial contributions to the world economy and account for the great majority of entities globally. Simultaneously, increasingly complex structures and transactions need to be addressed in the International Standards on Auditing (ISAs). Accordingly, IAASB issued the Exposure Draft on ISA for LCE in June 2021 for stakeholders comments. The ISA for LCE:

- is a standalone "self-contained" standard designed specifically for audits of a less complex entities;
- is developed to be more understandable, straightforward and concise;
- is based on the underlying core concepts from ISAs and does not allow to refer back to the ISAs for its application;
- utilizes a risk-based approach to an audit with requirements that are principles-based;

The new ISA for LCE will be effective for audits of financial statements for periods beginning on or after December 15, 2025, with early adoption allowed.

The IAASB is now focused on supporting stakeholders' adoption and implementation efforts through issuance of non-authoritative supplemental guides on the Authority of the standard and reporting under the standard, a first-time implementation guide and other guidance material.

Proposed ISSA 5000: IAASB's Global Outreach Campaign

The proposed ISSA 5000 was issued by the International Auditing and Assurance Standards Board (IAASB) in August 203 to serve as a comprehensive, stand-alone standard suitable for any sustainability assurance engagements. It will apply to sustainability information reported across any sustainability topic and prepared under multiple frameworks, including the recently released IFRS Sustainability Disclosure Standards S1 and S2. The comment period for proposed ISSA 5000 was December 1, 2023.

IAASB is also committed to an extensive, high-level outreach plan to ensure broad stakeholder input to improve the quality of the final standard. The outreach plan included in-person roundtables around the world, virtual webinars for global audiences, and regional and national meetings with regulators and oversight bodies.
