ICAP & CCP jointly launch a Continuing Professional Development (CPD) program

A delegation from ICAP visited CCP to discuss potential areas of collaboration. The meeting was attended by Mr. Salman Amin, Member CCP; Mr. Shahzad Hussain, DG Legal & Advocacy CCP; Mr. M. Ali Latif, President ICAP; Mr. Arslan Khalid, Vice President ICAP; Mr. Asad Feroze, Vice President ICAP; and Mr. Ashfaq Tola, Former President ICAP.

During the meeting, Mr. Salman Amin expressed that the CCP places high importance on creating awareness of a free and fair competitive environment. Given that ICAP members serve in various sectors, it is imperative for them to have a better understanding of competition law. The meeting explored potential collaboration in areas such as forensic auditing, advanced cost auditing techniques, and addressing deceptive marketing on digital platforms.

It was agreed that, as part of the CPD program, a series of training courses covering specialized modules on Competition Law will be held. Initially, three CPD training modules will be conducted in Karachi, Lahore, and Islamabad. These CPD training modules will empower ICAP members with a deeper understanding of competition law and provide guidance to businesses on competition compliance.

CCP is mandated under Section 29 of the Competition Act, 2010, to engage in advocacy through various means to create awareness of competition issues and to promote a culture of competition in the country. CPD training is an important step towards professional growth, allowing association members to continuously improve their skills and knowledge of competition law.

Finance Leader 2.0-Reinvented Training Program -



In an ever-changing world, the role of financial leaders is more critical than ever before. To equip finance professionals with the skills and insights needed to thrive in this dynamic landscape, the Professional Accountant in

Business Committee of ICAP of the Institute of Chartered Accountants of Pakistan conducted the "Finance Leader 2.0-Reinvented" training program. This transformative program, held on September 6th, 7th, 11th, and 12th, 2023, in Karachi, marked the third edition of the Finance Leader 2.0 series, initiated back in 2021 with the generous support of the International Federation of Accountants (IFAC).

Mr. Samiullah Siddigui, Chairperson of the PAIB Committee, highlighted the importance of finance professionals in the changing dynamics of doing business in his opening remarks. He affirmed that the finance professional's role goes beyond numbers. Therefore, it is of utmost importance that they should be trained to transition from the role of finance to business partner and leadership roles. He explained that over the course of four intensive days, this program delves into key aspects of leadership, including "Leading Self," "Leading Change," "Leading Strategy," and "Leading Culture." The program aims to empower finance professionals, enabling them to excel in their pivotal roles within their respective organizations. What sets this program apart is its unique approach of blending knowledge acquisition delivered by industry mentors, with Farhad being the lead facilitator, stitching it with internationally accepted content.

Dr. Farhad Karamally kicked off the program by encouraging participants to explore their thinking preferences and what drives them as leaders. Through HBDI self-assessment analysis, attendees gained valuable insights into their thinking preferences, both in general and under pressure.

One of the program's distinguished speakers, Mr. Stathis Gould, Director of IFAC, shared his expertise on leading

strategy. He emphasized the five major themes essential for a "Future Fit" finance leader: value, orientation, role, mindset, and skills and capabilities. He underscored the need for finance leaders to adapt to the evolving global landscape, focusing on business and value partnering to enhance strategic decision-making.

Throughout the program, industry mentors from diverse sectors shared their leadership journeys, offering invaluable insights into personal, professional, people, and strategic leadership. Mr. Aamir Ali, CEO of Bank Islami Limited, emphasized the significance of competencies and attitude in leadership, highlighting traits such as courage, vision, confidence with competence, and the willingness to learn.

Mr. Murtaza Abbas, CEO of International Business at Lucky Cement Limited and Chief Strategy Officer, encouraged participants to reflect on their life's purpose. He emphasized the impact of change and the need for organizations to adapt to micro and macroeconomic factors in today's rapidly evolving world to avoid becoming obsolete in the market, unlike giants like Nokia and Yahoo.

The "Leading Strategy" module featured insights from Mr. Aly Yusuf, Director & CFO of Unilever Pakistan Limited & Unilever Pakistan Foods Limited, who discussed Unilever's strategies related to Net Zero, Plastic Neutrality, and ESG. He stressed the importance of collaboration, research, and building trust to inspire teams and formulate effective strategies.

Mr. Khalilullah Shaikh, Former President ICAP, shared his experiences in dealing with unforeseen challenges, particularly during the COVID-19 pandemic. He highlighted the importance of resilience, delegation,



teamwork, and data-driven decision-making in navigating complex situations.

The program also explored the critical aspects of "Leading Culture." Ms. Gulzar Khoja, CFO of Pakistan State Oil Limited, shared her personal journey and how her cultural upbringing influenced her professional path. She emphasized the role of culture in leadership and the need for vision, resilience, and readiness to drive change.

As change is the only constant phenomenon, 88% of the Fortune 500 companies that did not embrace change became obsolete over the last sixty years.

The four-day training program concluded with a grand closing ceremony, underscoring the significance of leadership programs for finance professionals. Ms. Shagufta Hassan, FCA- Vice President Finance & CFO of AKU, graced the event as the chief guest, while Mr. Farrukh Rehman, Partner A.F Ferguson & Co., and Council Member ICAP, delivered the keynote address. Participants received certificates of participation, and industry mentors were recognized for their contributions.

Overall, participants from thirty organizations left the program with a wealth of knowledge, including insights from HBDI assessments, leadership styles, industry perspectives from mentors, and valuable networking opportunities. Professional Misconduct

Findings and Decision of the Council under Section 20I of the Chartered Accountants Ordinance, 1961

It was noted with reference to the Quality Control Review (QCR) report of the firm that the audits carried out and audit reports issued by a practicing member of the Institute in respect of two Private Limited Companies (the Companies) for the year ended June 30, 2017 were not in accordance with the International Standards on Auditing (ISAs) and legal and regulatory requirements as applicable in Pakistan:

- There were irregularities in the financial statements of the Companies for the year ended June 30, 2017 including non-compliance with the relevant requirements of Fifth Schedule to the Companies Ordinance, 1984 and International Financial Reporting Standards (IFRSs) such as International Accounting Standard (IAS) 1 (Presentation of Financial Statements), IAS 16 (Property, Plant and Equipment), IAS 24 (Related Party Disclosures) etc. The member failed to address the said irregularities, while conducting the audit of aforesaid financial statements, as per the requirements of the International Standards on Auditing as applicable in Pakistan including ISA 705 (Modifications to the Opinion in the Independent Auditor's Report) and Section 249 of the Companies Act, 2017; and
- There are various instances, where, while conducting the audit of aforesaid financial statements:
- The member failed to follow the applicable requirements of ISAs such as ISA 240 (The Auditor's Responsibilities Relating to Fraud in an Audit of Financial Statements), ISA 250 (Consideration of Laws and Regulations in an audit of Financial Statements), etc.;

- The member failed to obtain sufficient appropriate audit evidence as per the requirements of the relevant ISAs including ISA 500 (Audit Evidence) regarding various account balances appearing in the statement of financial position/balance sheet and the classes of transactions appearing in the profit and loss account and disclosures in the financial statements so as to be able to draw reasonable conclusions for forming an opinion on the financial statements; and
- The member failed to prepare the complete audit documentation in the working paper files, as per the requirements of the relevant ISAs such as ISA 230 (Audit Documentation) etc.

The member failed to comply with the requirements of the relevant laws and regulations and the applicable technical and professional standards including ISAs as applicable in Pakistan while carrying out the subject audits. Hence, he was negligent in the conduct of his professional duties in this regard.

In view of the above and after considering the report of the Investigation Committee, the information and evidence available on record and the submissions made by the member during his hearing, the Council decided to hold the member guilty of professional misconduct under:

- Clause (3) of Part 4 of Schedule I of the Chartered Accountants Ordinance, 1961 for not complying with the fundamental principles stated in Paragraphs 100.5(c) (Professional Competence and Due Care) and 100.5(e) (Professional Behavior) of the Code of Ethics for Chartered Accountants (April, 2015) contained in Directive 6.04 of the Institute, and
- Clause (5) of Part 4 of Schedule I of the Chartered Accountants Ordinance, 1961 for being guilty of an act or default discreditable to a member of the Institute.

The Council decided to reprimand the member under Section 20D of the Chartered Accountants Ordinance, 1961.



It was noted that a practicing member of the Institute was engaged in other occupations while being a practicing member of the Institute which results in professional misconduct under the provisions of the Chartered Accountants Ordinance, 1961 and Chartered Accountants Bye-Laws, 1983.

In view of the above, after considering the report of the Investigation Committee, the information and evidence available on record and the submissions made by the member during his hearing, the Council decided to hold the member guilty of professional misconduct under:

- Clause (10) of Part 1 of Schedule I of the Chartered Accountants Ordinance, 1961 for engaging in any business or occupation other than the profession of Chartered Accountants without permission of the Council so to engage;
- Clause (3) of Part 4 of Schedule I of the Chartered Accountants Ordinance, 1961 for not complying with the fundamental principle stated in paragraph 110.1 A 1 (e) (Professional Behavior) of Code of Ethics for Chartered Accountants (Revised 2019) contained in Directive 6.04 of the Institute: and
- Clause (6) of Part 4 of Schedule I of the Chartered Accountants Ordinance, 1961 for contravening the provisions of the Chartered Accountants Bye-Laws, 1983.

The Council decided to reprimand the member under Section 20D of the Chartered Accountants Ordinance, 1961.

ICAP members comments requested on Adoption and Implementation of IFRS Sustainability Disclosure Standards (IFRS S1 and IFRS S2) in Pakistan

With the issuance of two global baseline Sustainability Disclosure Standards, IFRS S1 'General Requirements for Disclosure of Sustainability-related Financial Information' and IFRS S2, 'Climate-related Disclosures' by International Sustainability Standards Board (ISSB), all the jurisdictions around the world are working immensely to adopt these standards in their regions.

The Accounting Standards Board (ASB) of ICAP is also cognizant of international developments in sustainability reporting. The ASB, through its various initiatives, has been promoting the relevance of sustainability, climate change, and related advances to business strategy to the stakeholders and the chartered accountant's role in advancing these agendas. The ASB is also taking steps to promote awareness and to enhance capacity building of the members and the relevant stakeholders for the adoption and implementation of aforementioned IFRS Sustainability Disclosure Standards in Pakistan.

As a critical step to the process of adoption of abovereferred standards, ASB has requested member's comments and feedback on the adoption of IFRS S1 and IFRS S2 in Pakistan through Circular 05/2023 (dated August 25, 2023). Comments were requested by September 15, 2023.

Corporate Regulatory Updates

SECP forms Committee with ICAP and PIDE to encourage corporatization

The Securities and Exchange Commission of Pakistan (SECP) has formed a Committee in collaboration with ICAP and the Pakistan Institute of Development Economics (PIDE) to promote corporatization.

The Committee is responsible to review of the existing regulatory structure, identifying impediments, and providing practical recommendations, including fiscal reforms, to encourage corporatization for sustainable economic development.

SECP issued Shariah Governance Regulations, 2023

SECP has recently issued the Shariah Governance Regulations, 2023. These regulations mark a major overhaul of the prior Shariah Governance Regulations of 2018 and the Shariah Advisors Regulations of 2017.

A new framework introduces several pivotal changes including the following:

- introduction of voluntary Shariah supervisory boards, providing organizations with the option to establish dedicated bodies for overseeing compliance with Shariah principles.
- a comprehensive framework for Shariah stock screening of listed securities.
- elimination of the need for periodic renewal of Shariah-compliant securities.
- the qualifications and experience prerequisites for Shariah advisors have been strengthened.



- the powers and functions of Shariah advisors have been redefined
- the introduction of a standardized format for independent assurance reports by external Shariah auditors, aligning with the ICAP's recommendations shared with SECP on the shariah audit report format.

IASB proposes annual improvements to IFRS Accounting Standards

The International Accounting Standards Board (IASB) has published proposed narrow-scope amendments to IFRS Accounting Standards and accompanying guidance as part of its periodic maintenance of the Accounting Standards.

The proposed amendments include clarifications, simplifications, corrections or changes to improve consistency in IFRS 1 'First-time Adoption of International Financial Reporting Standards', IFRS 7 'Financial Instruments: Disclosures' and its accompanying Guidance on implementing IFRS 7, IFRS 9 'Financial Instruments', IFRS 10 'Consolidated Financial Statements', and IAS 7 'Statement of Cash Flows'. The comment period is till December 2023.

The next IFRS Accounting Standard

The IASB's new Standard on 'Primary Financial Statements' will affect all companies and will improve the information companies provide about their financial performance. It will give investors better information to enable better decisions.

The new Standard, IFRS 18, will replace IAS 1 Presentation of Financial Statements. The new Standard will introduce three key improvements. It will bring more rigor to the statement of profit or loss by requiring companies to present two new mandatory subtotals, including operating profit. It will allow companies to include management-defined performance measures with certain requirements as to how they are presented to provide transparency. It will also provide new guidance on grouping of the information if provided on 'the face' of the financial statements or in the notes. The new Standard is expected to be issued in the second quarter of next year 2024.

Proposed new standard for Audits of Less Complex Entities

In response to a need for a set of high-quality requirements tailored for the audits of less complex entities, the IAASB in 2021 issued an Exposure draft of the proposed standard for the Audits of Less Complex Entities (ISA for LCE). Initially, the Group audits were not included in the scope of the original exposure draft of the proposed standard, however, keeping in view of stakeholder's feedback, the IAASB reconsidered and added new part 10 on Group Audit to address audits of less complex groups.

The final standard is expected to be issued in December 2023 which will meet the growing global need for a separate standard for audits of less complex entities, while reducing the emerging risk of jurisdictional divergence.

Management Time: Who's Got the Monkey?

Managing time effectively involves understanding three types of time in a managerial context:

- 1. Boss-imposed time: Tasks assigned by superiors that must be completed to avoid penalties.
- 2. System-imposed time: Tasks required by peers or colleagues for collaboration and support.
- Self-imposed time: Tasks initiated by the manager or agreed upon, providing discretionary control over activities.

To enhance productivity and regain control over time:

- Transfer initiative to subordinates, allowing them to take responsibility and act independently within agreed frameworks.
- Establish clear rules for handling tasks ("monkeys") and set specific times for addressing them.
- Prioritize tasks effectively to optimize managerial efficiency and ensure important activities receive appropriate attention and focus.
