

#### **ICAP Updates**

Seminar on Calculation of Green House Gas (GHG) Emissions - Implementation of IFRS Sustainability Disclosure Standards in Pakistan

The Institute of Chartered Accountants of Pakistan (ICAP) has organized a seminar on January 09, 2024 as a part of its ongoing initiatives to promote capacity-building activities for the industry and other stakeholders with regard to the adoption and implementation of IFRS Sustainability Disclosure Standards.

The seminar covered the topic of GHG emissions calculations in the context of IFRS S2, Climate-Related Disclosures. IFRS S2 necessitates companies to reveal information on the climate-related aspects of their operations, including their Scope 1, Scope 2, and Scope 3 GHG Emissions. The seminar included presentations from Mr. Arslan Khalid (Council Member ICAP), Mr. Akif Saeed (Chairman of SECP), Mr. Ravi Abeywardena (Director of IFRS Foundation) and Ms. Fauzia Safdar Khan (Director Sustainability of Crowe Hussain Chaudhry & Co.). The presentations were followed by the panel discussion on climate change including sustainability experts form practice, industry etc.

Report on IFRS Sustainability Disclosure Standards - Study, consultation and recommendations for implementation in Pakistan

The Accounting Standards Board of the Institute has issued Report on IFRS Sustainability Disclosure Standards through its Circular No. 11/2023 dated December 28, 2023. The Board has diligently worked on the proposed adoption and implementation of IFRS Sustainability Disclosure Standards in Pakistan.

The report outlines the comprehensive study conducted, including insights gathered from extensive consultations with companies, auditors, and stakeholders in recent months. The collective perspectives and feedback received during these sessions are reflected in the report.

Amendments to IAS 1 and consequential impact on the Auditor's Report

The Institute has issued Circular No. 01/2024 dated January 26, 2024, addressing 'Amendments to IAS 1 and its consequential impact on the Auditor's Report: Disclosure of Material Accounting Policy Information'.

Effective for annual reporting periods starting on or after January 1, 2023, the International Accounting Standards Board (IASB) amended IAS 1, Presentation of Financial Statements, in February 2021. As per the amendment, companies are now required to disclose 'material accounting policy information' instead of 'a summary of significant accounting policies.'

In response to this IASB amendment, the International Auditing and Assurance Standards Board (IAASB) has updated the illustrative auditor's reports in the Appendix to ISA 700 (Revised), Forming an Opinion and Reporting on Financial Statements. For audits of financial statements in Pakistan following International Financial Reporting Standards from January 1, 2023, onward, auditors are now required to use the term 'material accounting policy information' in their auditor's report issued under ISA 700 (Revised) and the Companies Act, 2017, in place of the old term 'a summary of significant accounting policies.'

# Amendments to Auditors (Reporting Obligations) Regulations, 2018

The Securities and Exchange Commission of Pakistan (SECP) through its S.R.O. 9 (I)/2024 (dated Jan 02, 2024) has made amendments to the Auditors (Reporting Obligations) Regulations, 2018.

As per SRO, new regulation (6A) has been added, making it mandatory for auditors to include UDIN (Unique Document Identification Number) in all reports issued under these regulations. To ensure compliance, it is essential to incorporate the term "UDIN" after the word "date" in annexures I to VI of the said regulations.

# Requirement to mention UDIN in Audit Reports of Modaraba companies and Modarabas

SECP, through its Directive No. 2 of 2024 (dated Jan 17, 2024) has mandated all Modaraba companies and Modarabas to ensure that their auditors mention the UDIN on both initial and revised audit reports The UDIN should be generated from the designated portal of ICAP.

#### **Amendments to Insurance Rules, 2017**

SECP has made amendments to Insurance Rules, 2017 through its SRO 1871(I)/2023 dated December 26, 2023. As per SRO the limit to annual supervision fee to be paid by an insurer in terms of clause (c) of sub-section (3) of section 11 of the Insurance Ordinance 2000 has been increased to rupees one hundred million. Previously maximum limit to the Annual Supervision Fee to be paid by an insurer was rupees fifty million.

The new resource helps companies that already use GRI Standards for reporting greenhouse gas emissions to easily align with IFRS S2 and is designed to make reporting more efficient for companies that follow both ISSB and GRI Standards.

Updates from the International Auditing and Assurance Standards Board (IAASB)

#### IAASB Opens Public Consultation on Narrow Scope Amendments to meet Expectations for Public Interest Audits

The International Auditing and Assurance Standards Board (IAASB) has initiated a consultation on proposed changes to align more closely with the International Ethics Standards Board for Accountants (IESBA) International Code of Ethics for Professional Accountants (Including Independence Standards) (IESBA Code).

The revisions aim to synchronize definitions and requirements in IAASB standards with the IESBA Code. Additionally, the proposed amendments extend certain requirements for listed entities to meet increased expectations for auditing public interest entities (PIE).

Key changes include broader applicability of ISQM standards and ISAs, encompassing engagement quality reviews, enhanced transparency in auditor reports including auditor independence, key audit matters, and the engagement partner's name, and improved communication with those overseeing financial reporting.

The ED on International Ethics Standards for Sustainability Assurance (IESSA) offers a clear guidance on expected behaviors and ethics provisions for use by all sustainability assurance practitioners including professional accountants. The standard aims to mitigate greenwashing and elevate the quality of sustainability information. Comments on the ED are requested by May 10, 2024.

The ED on Using the Work of an External Expert offers guidance to professional accountants or sustainability assurance practitioners, in assessing whether an external expert has the required competence, capabilities and objectivity to use the work of an expert for the intended purposes. Comments are requested by April 30, 2024.
